# Seneca Falls Development Corporation Annual Meeting & Board of Directors Meeting - Minutes December 10, 2018

The Seneca Falls Development Corporation (the "SFDC" or the "Corporation") Board of Directors met on Monday, December 19, 2018 in the main conference room in the Generations Bank Headquarters at 20 East Bayard Street, Seneca Falls, New York.

Board members Joell Murney-Karsten, Dave Delelys, Gerald Graziano, Greg Lazzaro, Ken McConnell and Diana Smith were present. Also attending was Greg Zellers, Director of the Seneca Falls Development Corporation. Chairwoman Joell Murney-Karsten presided over the meeting and Mr. McConnell recorded the minutes. The meeting was called to order at 5:00 PM.

## **Prior Meeting Minutes Approval**

The November 13, 2018 meeting minutes were presented by Mr. McConnell and were moved for approval with corrections as noted (incorrect date) on a motion by Mr. Delelys, seconded by Mr. Graziano and unanimously approved by the Board.

# Treasurer's Report

Mr. Graziano briefly presented the Treasurer's report for November, which is attached. He mentioned that a bank account balance was approximately \$123,500. Expenses for the period included Mr. Zellers fee and routine depreciation and amortization expenses. Mr. McConnell moved to accept the Treasurer's report. The motion was seconded by Mr. Lazzaro and then unanimously approved by the Board.

#### **New Business**

Greg Zellers reported details on the Brownfield grant. The property seeking review is the Seneca Falls Machine property. An explanation of the process, advantages and disadvantages was offered by Greg Zellers. The Sylvania plant was discussed. It is owned by Verizon and they are liable for repairs to the property.

#### 2020 Celebration

A video was made to forward to Ellen DeGeneres to entice her to film a show here. Other items discussed were hiring an Event Coordinator, compensation? Attrutes required are experience, education, contacts, marketing background, etc../ Will the Town be funding these efforts? A committee needs to be formed to create a vision and determine scope of celebration. Are there available State and/or Federal funding or grants available for this?

#### 2019 Action Items

Ideas discussed were bringing Doug Finch (Town Manager of Canandaigua) to Seneca Falls to meet with the board and discuss best practices.

Begin an assessment of at-risk companies. Begin discussion with these committees (HPC, Zoning and Planning) to identify problems/barriers. Create info center for those looking top get a project moving forward. Management of the public image or perception to focus on positive and not negative coverage of economic development. Create strategic plan to address this.

Regular update to news media or have a column

Invite IDEA/Chamber/County or other partners to review action items at January meeting

Gerry Graziano proposed hiring an Accounting firm, This idea needs to be explored
